

Market Comment | Steady markets in an eventful day

Global Financial Markets Unit
15 Mar 2018

- **Financial markets continued steady for another session**, with no major events and no major economic data being released.
- **Stock prices inched up, led by US stocks**, as traders are already looking forward to next week's Fed monetary policy meeting. European stocks showed a mixed performance, with cyclicals and the technology sector outperforming.
- **Sovereign bond yields again fell slightly as investors mulled over US trade protectionism** after a new White House appointee took a tough line on China ([see](#)).
- **Emerging currencies declined across the board as the USD appreciated slightly**, especially the RUB after the US slapped sanctions on **Russia for meddling in the 2016 US elections** ([see](#))
